SELEZIONE ATLETI KUMITE CONTATTO PIENO

The selections will be carried out to identify WUKF ITALIA PRO fighters who will be entitled to participate in our full contact kumite events.

To participate, you must register by May 15, 2024 on the www.wukf-italia.it portal by entering the following data:

- Sports curriculum
- Card number of the association you belong to
- Sports promotion body affiliation card number with the type of insurance policy indicated
- Videos of kumite matches during sports competitions and training

The Karate PRO Committee will view the material sent and communicate to the Board of Directors the list of candidates admitted to the final selection phase.

The Board of Directors, after verifying the correspondence of the data sent, will communicate to the candidate by email of his acceptance or exclusion by 31 May 2024.

During the final selection phase, meetings will be held divided by category and gender, supervised by the Karate PRO Committee and directed by the WUKF ITALIA competition officials.

KATA PRO COMPETITION

The Kata PRO competition will take place without division into categories by age and style, distinguished by males and females.

Athletes from CADETS to VETERANS can participate according to the classification reported in the WUKF regulations.

The athlete must perform a tokui kata chosen from those listed in the WUKF regulations and a freestyle kata, as per the WUKF ITALIA PRO regulations.
